NOW, BE IT RESOLVED by the Township Board of Center Township, Boone County;


THAT pursuant to law, it is hereby resolved that the salaries stated below be fixed for the officers and employees of the township for the year 2023.





**EXHIBIT 1**

Full Time base salary is \$56,400.00 per year.

During the first year of employment, the firefighter will be paid \$50,000.00 per year as a probationary period.

After one year of service, pay will increase to the base salary of \$54,000.00

After 3 years of service, full time employees will be entitled to longevity pay of an additional 0.5% of the year's base salary per years of service.

**EXAMPLE**

Years of Service	Salary
0-1 Year (Probationary Period)	\$56,400
1 Year	\$56,400
2 Years	\$56,400
3 Years	\$56,682
4 Years	\$56,964
5 Years	\$57,246
6 Years	\$57,528
7 Years	\$57,810
8 Years	\$58,062

If a full time employee meets the qualifications and is approved by the Fire Chief and Trustee to be promoted as an Officer of the department, the employee is entitled to an additional \$3,000.00 to their salary. Promotions are not retroactive.

Employees must meet these minimum qualifications in order to be promoted as an Officer:

- Firefighter I/II
- Emergency Medical Technician or Higher
- Driver Operator
- Instructor I
- Officer I

EXHIBIT 2

Part Time firefighters of the township are paid on an hourly basis.

The base pay for part time firefighters is \$15.00 per hour.

Depending on the level of experience and with approval of the Fire Chief, employees are entitled to the compensation as described below if they are scheduled to work the following positions:
